

Burnt Hills-Ballston Lake Central School District School Reopening COVID-19 Layered Mitigation Protocols Fall 2021 (09-29-2021)

The Burnt Hills-Ballston Lake School District is planning for a full return to school in September. As we know, unfortunately the pandemic is still with us. While we want to see as much normalcy as possible, we must also prepare for peaks and valleys in the rate of transmission of this virus this year. The NYS Department of Health is expected to provide direct regulations that will govern much of the implementation of layered mitigation to prevent the spread of COVID-19. In addition to following the regulations provided by the NYSDOH, we will use guidance from the CDC, the NYS Department of Education, our county health officials, and our school physician to advise the plan. This plan was approved by the BHBL Board of Education on 9-7-2021

Monitoring Local Data

In order to help our families stay informed of the levels of COVID in our BHBL community, we will be monitoring local data at the county, town, and building level. At the **county level** we will monitor the CDC's *level of transmission*. The *level of transmission* is based on two factors- 1) the number of new cases in the county over the previous 7 days; and 2) the percentage of accurate COVID tests (Nucleic Acid Amplification Tests or NAATs) that come back positive in the county over the past 7 days. The determination of a specific *level of transmission* follows these guidelines:

In addition to monitoring the Schenectady and Saratoga county levels of transmission, we will monitor data at the **town level-** specifically the number of *active cases* in Ballston, Charlton, Glenville, and Clifton Park every day. We will publish the updated **county and town data** regularly on our web page (link) for ease of access. All of relevant source data can be found in the following locations:

In addition to county and town data, we will consider **building-level** data through *random pool testing* within the district if this program becomes available through our counties. This pool testing would enable us to <u>directly measure if the virus is present in our schools</u>. The pool testing is saliva-based and non-invasive. (Note: If we implement this screening, parents would be given the ability to opt-out.)

LEVELS OF RESPONSE

We will use this chart as a communication tool for letting parents and students know what the expectations are. The level response will be chosen at the direction of CDC and Department of Health Guidance. The chart describes briefly the mitigation protocol we will utilize in each area of focus. This tiered mitigation strategy is fluid and the Board of Education authorizes the superintendent to make any adjustments necessary to match CDC/DOH guidance.
